



▲ STATEMENT OF FEES

Professor Lynn Corcoran Early Learning Centre: FROEBEL Parkville

Daily Fees from 1 January 2024:

Daily fees are payable **two weeks in advance** and are collected by direct debit (nominated bank account or credit card) on Thursdays for the fortnight commencing on the following Monday. Direct debits against a nominated Australian bank account are processed **free of charge**. For credit card payments, a surcharge is charged by Debitsuccess, please review your Direct Debit Agreement for details).

Notes:

¹ Daily fees depend on the family's individual eligibility to claim Child Care Subsidy (CCS) as a reduction of fees. Please speak to Centrelink about your CCS entitlements. Families will be asked to pay full fees until CCS confirmation is received by the Centre. CCS is estimated for current and future weeks and may be adjusted by Centrelink. Upon termination of your enrolment, you may be liable for any residual fee if CCS percentages have been overestimated.

² Families with 3+ and 4+ year old children must nominate FROEBEL as their Kindergarten of choice for funding purposes in the last two years before primary school to benefit from the discounted 'funded' fees.

For families who do not nominate FROEBEL to deliver the funded Kindergarten Program, or families whose child/ren already attend a funded Kindergarten Program at another service, daily fees are higher to cover a part of the kindergarten funding that FROEBEL is unable to claim for these children ('unfunded' fees). Families will be asked annually to nominate FROEBEL through an online confirmation form.

If a child is unable to transition to the Kindergarten room for their three-year old Kindergarten program due to non-availability of places but is eligible for kindergarten funding, the funded Kindergarten fee will apply even before the child is able to transition to the Kindergarten room.

An additional amount of up to \$2,000 per child per annum will be paid to Kindergarten Program providers by the Victorian Government. Families nominating FROEBEL to deliver the funded Kindergarten Program will receive a weekly fee reduction in the amount of \$39.22 for up to 51 weeks (= FROEBEL's operating weeks) equalling a total of up to \$2,000 per annum per eligible child.



³ Early Start Kindergarten grants from the Victorian Government support the participation of Aboriginal and Torres Strait Islander children, children of Refugee or Asylum Seekers and children who are known to Child Protection. FROEBEL will credit received ESK funding to eligible family accounts as a fee reduction for up to 15 hours per week or 600 hours per annum over the duration of up to 40 weeks per year. Please speak to the Centre Director if you believe you are eligible.

⁴ Please note that FROEBEL Parkville will be closed between 25 December 2023 and 1 January 2024, as well as between 25 December 2024 and 1 January 2025. Public holiday fees apply as per usual; daily fees will not be charged on business days during the end-of-year closing period.

⁵ From 1 July 2024, the Daily Fee for children under 3 years of age and children in unfunded Kindergarten will increase to \$170.60 before CCS, and the Daily Fee for children older than 3 years of age in funded Kindergarten to \$154.50 before CCS. A 5% surcharge will apply to Casual Extra Day Fees. A revised Statement of Fees reflecting these changes will be issued to enrolled families in due course.

⁶ All fees are subject to annual review.

Other Fees:

Waiting List Registration Fee (non-refundable)	\$40.00 per child (currently waived for all families until further notice)
Enrolment Fee (non-refundable)	\$85.00 per child, charged at the start of the enrolment
Late Fee (applicable only if children are picked up after 6:00pm to compensate overtime payments to educators)	\$15.00 for the first 10 minutes or part thereof, and an additional \$10.00 for every 5 minutes or part thereof after 6:10pm.
Direct Debit Dishonour Fee	\$10.00 for each unsuccessful transaction <i>An additional service fee may be charged by Debitsuccess for unsuccessful transactions.</i>
Access Card Fee for Forecourt Drop Off and Pick Up Parking (refundable upon return of the Access Card to FROEBEL, T&C apply)	\$15.00 per Access Card
