Daily Fees from 1 July 2024:

Daily fees are payable **two weeks in advance** and are collected by direct debit (nominated bank account or credit card) on Thursdays for the fortnight commencing on the following Monday. Direct debits against a nominated Australian bank account are processed **free of charge**. For credit card payments, a surcharge is charged by Debitsuccess, please review your Direct Debit Agreement for details). Fees are subject to annual review.

¹ Daily fees depend on the family's individual eligibility to claim the Child Care Subsidy (CCS) as a reduction of fees. Please speak to Centrelink about your CCS entitlements. Please note that you will be asked to pay full fees until CCS approval has been granted and until CCS confirmation is received by the Centre. The CCS is estimated for current and future weeks and may be adjusted by Centrelink. Upon termination of your enrolment, you may be liable for any residual fee if the CCS rebates have been overestimated.

² The NSW Government's Start Strong Long Day Care program provides financial assistance to families with preschool-aged children. **Families with children who are at least 3 years old by 31 July 2024** who are choosing to access the fee relief payment at Fröbel will receive a weekly pro-rata credit of \$9.80 for up to 51 weeks (equalling a total of up to \$500 per annum per eligible child). **Families with children who are at least 4 years old by 31 July 2024** who are choosing to access the fee relief payment at Fröbel will receive a weekly pro-rata credit of \$41.37 for up to 51 weeks (equalling a total of up to \$2,110 per annum per eligible child). The weekly credits will go towards their fee payment.

³ Please note that Fröbel St Leonards will be closed between 25 December 2024 and 1 January 2025. Public holiday fees apply as per usual; daily fees will not be charged on business days during the end-of-year closing period.

Other Fees:

Waiting List Registration Fee* (non-refundable)	\$40.00 per child (*waived for all families during the FY2024-25)
Enrolment Fee (non-refundable)	\$85.00 per child, charged at start of enrolment
Late Fee (applicable only if children are picked up after 6.00pm)	\$15.00 for the first 10 minutes or part of, and an additional \$10.00 for every 5 minutes or part of after 6.10pm. <i>Please note:</i> The Late Fee is designed to compensate for overtime payments to educators.
Direct Debit Dishonour Fee	\$10.00 for each unsuccessful transaction <i>An additional service fee may be charged by Debitsuccess for unsuccessful transactions.</i>
